Survey of Preschool Students for Kindergarten Enrollment

Dear Hayfield Elementary School Parents and Guardians,

Each spring, Fairfax County Public Schools sends a survey to families <u>within its attendance</u> <u>area</u> to determine the number of rising kindergarten students that will attend district schools during the upcoming academic year. On the reverse side of this letter you will find that survey.

Parents/Guardians of rising kindergarten students **living within the Hayfield Elementary School boundaries** are asked to complete the Survey of Preschool Students for Kindergarten Enrollment and return it to our school office no later than **Thursday, March 31, 2020.** Please share with neighbors to whom this may apply. Additional copies will be available in our school office for parents/ guardians who do not currently have a student enrolled at Hayfield Elementary School. Please note the following when determining whether or not you should complete the survey:

- 1. A child who will reach his or her fifth birthday **on or before September 30, 2020** is eligible to register for kindergarten.
- 2. The child's record of immunization, physical examination, and birth certificate must be submitted when registering your child/children, as well as the family's proof of residency (copy of lease or deed).

We are working on an exciting new orientation experience tentatively scheduled for the evening of May 5, 2020, and will have more details available soon. In the meantime, kindergarten (and new student) registration appointments are available for scheduling through our website: https://hayfieldes.fcps.edu/parent-resources/student-registration.
